Each person authorized by this Order shall present a copy of this Order to security personnel each time the person enters the Courthouse with such equipment. Courthouse security personnel will require the authorized person to present a valid Bar Identification, if applicable, as well as picture identification at the time of entry.


The equipment is subject to inspection at any time by courthouse security personnel. Equipment shall not be fitted with video or audio recording devices and must have all sound muted while in use in the courtroom. The equipment may not be connected to the Judiciary's computer network within the Courthouse. Pending a determination of court-wide policy, the

judge presiding over a particular matter, in his or her discretion, will determine if internet access will be allowed in that judge's courtroom on a case-by-case basis.

The Clerk of the Court shall ensure a copy of this order is provided to appropriate security personnel and to each person authorized use of a notebook computer while in the Courthouse.

This Order replaces Administrative Order TPA-2011-14, which shall be archived. This Order is effective February 1, 2012 and shall expire at midnight on February 29, 2012.
