PURSUANT TO 11 U.S.C. § 110(i)(1)**

These cases came before the Court upon
Motion for an Order: to Show Cause Regarding
Failure by Bankruptcy Petition Preparer to Comply
with 11 U.S.C. § 110 and for Unauthorized Practice
of Law; Certifying this Matter to the United States
District Court pursuant to § 110(i)(1); and for Further
Sanctions pursuant to § 110 filed in each of the cases
(collectively the "Show Cause Motions"). Upon

1. Robert Palmer is fined \$500.00 in each
of the above captioned cases for violating 11 U.S.C.
§§ 110(c)(1) and 110(f)(1) for a total of \$4,000.00,
payable to David K. Oliveria, Clerk of the Court,
United States Bankruptcy Court, 300 N. Hogan
Street, Suite 3-350, Jacksonville, FL 32202-4267.

2. Robert Palmer is enjoined from
advising debtors on the availability of exemptions,
advising debtors as to what property to retain or
surrender, and advising debtors as to whether to enter
into reaffirmation agreements and the effects thereof.

3. Pursuant to 11 U.S.C. § 110(i)(1) this
Order and the separate Findings of Fact and
Conclusions of Law are certified to the United States
District Court for further findings and sanctions as
the court may deem proper.
