JUDGMENT

This matter came before the Court on the Complaint Objecting to Discharge of Debtor (Doc. No. 1) filed by the Plaintiff Patina, Inc. against the Debtor/Defendant Michael Leshawn Banks. The final evidentiary hearing was held on August 26, 2009. After reviewing the pleadings and evidence, hearing live testimony and argument, and in conformity with and pursuant to the **Memorandum Opinion** entered contemporaneously herewith, it is

ORDERED, ADJUDGED and DECREED that Plaintiff's objection to venue is hereby **OVERRULED** and venue is proper in this Court pursuant to 28 U.S.C. Section 1403(1); and it is further

ORDERED, ADJUDGED and DECREED that the Debtor's Objection to Claim No. 8-1 (Main Case Doc. No. 33) is hereby **SUSTAINED IN PART** and Claim No. 8-1 is allowed as a general unsecured claim of \$13,435.80; and it is further

ORDERED, ADJUDGED and DECREED that the relief sought in the Plaintiff's Complaint pursuant to 11 U.S.C. Section 727(a) is hereby **DENIED** and **JUDGMENT** is hereby entered in favor of the Debtor/Defendant Michael Leshawn Banks and against the Plaintiff Patina, Inc.; and it is further

ORDERED, ADJUDGED and DECREED that the general discharge of the Debtor Michael Leshawn Banks is hereby **GRANTED** pursuant to 11 U.S.C. Section 727; and it is further

ORDERED, ADJUDGED and DECREED that Michael Leshawn Banks' indebtedness to the Plaintiff Patina, Inc. is **DISCHARGEABLE** and is hereby **DISCHARGED**; and it is further

ORDERED, ADJUDGED and DECREED that the relief sought in the Debtor's Counterclaim is hereby **DENIED** and **JUDGMENT** is hereby entered in favor of the Plaintiff Patina, Inc. and against the Debtor Michael Leshawn Banks.
