FINAL JUDGMENT


This cause came on for consideration, ex parte, on Order on Final Evidentiary Hearing entered herein, and the Court having considered the record and being otherwise fully advised in the premises, finds that the Defendant agreed that a Final Judgment should be entered in favor of the Plaintiff, it is, therefore

ORDERED, ADJUDGED and DECREED that final judgment is hereby entered in favor of the plaintiff, in the amount of \$10,196.70, plus costs of \$150.00, plus attorneys' fees of \$550.00, for a total of \$10,896.70, for which let execution issue, and it is further

ORDERED, ADJUDGED and DECREED that the Debtor shall make equal monthly payments in the amount of \$908.06 beginning December 10, 2005, with subsequent payments being due on the 10th day of each month until the entire balance has been paid in full. Said payments are to be made payable to Diane L. Jensen, Trustee, and mailed to P. O. Drawer 1507, Fort Myers, FL 33902-1507, and it is further

ORDERED, ADJUDGED and DECREED that ruling on the revocation of the discharge of MICHELLE L LABOUSIER be deferred. However, in the event Defendant failed to comply with the terms of this Final Judgment, the Plaintiff shall file a notice of the noncompliance and shall be entitled to the entry of an ex parte Amended Final Judgment for revocation of the Debtor's discharge, without further hearing.
