
**JUDGMENT**

THIS CAUSE came on for final evidentiary hearing on January 23, 2006, at 9:30 a.m. upon the Plaintiff's Complaint Seeking Declaratory Relief and Avoidance of Fraudulent Transfers. There appearing Alberto F. Gomez Jr. for the Plaintiff and Scott T. Orsini for the Defendants. The Court finds that notice was proper. The Court has considered the record, statements of counsel present, the proffer of evidence, and the exhibits filed and made a matter of record. For the reasons stated orally and recorded in court that shall constitute the decision of the Court, the Court finds in favor of the Plaintiff on Counts II, III and IV of the Complaint. It is thereupon ORDERED:

1. The Plaintiff is entitled to a Judgment against Arnaldo Pena, and Bellevue Hotel & Marina, Ltd ("Defendants") in the amount of One Hundred Thousand (\$100,000) Dollars or the value of the vessel identified on the record. The Defendants are jointly and severally liable for said Judgment amount.

2. The Plaintiff is due from Defendants the sum of \$100,000 as principal for all of which let execution issue. Interest shall accrue herein at the appropriate statutory rate which is currently seven (7%) percent per annum.
