Judgment

IT IS ORDERED THAT:

Williams, in the amount of \$8,000.00, which shall draw post-judgment interest at the federal rate of 3.76 %, for which let execution issue; and
- B. ANN BARBARA WILLIAMS, personal representative, administrator, trustee, or executrix under the Last Will and Testament of Margaret G. Williams, shall pay to Trustee, CAROLYN R. CHANEY, the additional sums of \$2,000.00 on October 31, 2005, October 31, 2006, October 31, 2007, and October 31, 2008, provided that Debtor is living on each such date.
