**FINAL JUDGMENT ON COMPLAINT TO DETERMINE  
DISCHARGEABILITY OF SPECIFIC DEBT**

THIS CAUSE came on for the Court's consideration of the parties' Joint Stipulation in Settlement of Complaint to Determine Dischargeability of Debt and the Motion to Approve the Joint Stipulation in Settlement of Complaint to Determine Dischargeability of Debt filed by the Plaintiff. The Court having granted said Motion and having approved said Joint Stipulation, it is hereby

ORDERED as follows:

1. A Judgment pursuant to 11 U.S.C. § 523(a)(2) is entered in favor of the Plaintiff, American Express Travel Related Services Company, Inc., (American Express"), and against the Defendant Todd O. Slayton determining that the Defendant's indebtedness to Plaintiff in regards to the credit cards with the Plaintiff is a nondischargeable debt. No interest shall accrue on the underlying indebtedness.
2. The amount provided for herein may be satisfied by paying a total of \$20,000.00 in the form of one lump sum payment of \$5000.00 immediately and 60

minimum monthly payments of not less than \$250.00 each. Said payments shall include the account numbers and shall be payable to "American Express", directly to Becket & Lee LLP, P.O. Box 3001 Malvern, PA 19355.

3. The balance of the Complaint relating to the Objection to Discharge shall be abated, but notice shall be given to the Trustee and all creditors that any party in interest may be substituted as party plaintiff and prosecute the 727(a) action within 30 days from the entry of this Judgment.
