CONSENT JUDGMENT

Plaintiff ROCKY DEAN THOMPSON and defendant UNITED STATES OF AMERICA, hereby stipulate and consent as follows:

1. As of October 12, 2005, debtor's assessed federal tax liabilities for tax years 1998, 2000, 2001, 2002 and 2003 are as follows:

2. The assessed federal income tax liabilities for tax years 1998, 2000 and 2001, as detailed above, are not excepted from discharge under 11 U.S.C. § 523 and are fully dischargeable.

3. The assessed federal income tax liability for the 2002 tax year, as detailed above, is excepted from discharge pursuant to 11 U.S.C. §§ 507(a)(8)(A) and 523(a)(1)(A) and is not dischargeable.


4. The assessed Trust Fund Recovery Penalty for the tax period ending December 31, 2003, as detailed above, is excepted from discharge pursuant to 11 U.S.C. §§ 507(a)(8)(C) and 523(a)(1)(A) and is not dischargeable.

5. All federal tax liens with respect to debtor's assessed federal tax liabilities, notices of which were properly recorded before October 16, 2005, as indicated above, shall remain in full force and effect as to any property, and any rights to property, belonging to debtor as of the filing of debtor's Voluntary Petition in bankruptcy.
