FINAL DEFAULT JUDGMENT

IT IS ORDERED AND ADJUDGED that, respecting Counts I and II of the Complaint filed in this Adversary Proceeding, Plaintiff David H. Crumpton, in his capacity as Distribution Trustee for the Distribution Trust of Northlake Foods, Inc. 
of this Final Default Judgment, plus post-judgment interest at the legal rate as provided by law from the date of this Final Default Judgment until paid in full, and for which let execution issue.

IT IS ORDERED AND ADJUDGED further that, further respecting Count III of the Complaint filed in this Adversary Proceeding, any claim of Defendant filed in Debtor Northlake Foods, Inc.'s bankruptcy case, including without limitation Defendant's Proof of Claim No. 97, filed November 13, 2008, is hereby disallowed unless and until Defendant pays all sums due pursuant to this Final Default Judgment.

IT IS ORDERED AND ADJUDGED further that, further respecting Count III of the Complaint filed in this Adversary Proceeding, any claim of Defendant filed in Debtor Northlake Foods, Inc.'s bankruptcy case, including without limitation Defendant's Proof of Claim No. 97, filed November 13, 2008, is hereby equitably subordinated to any and all allowed, non-insider, unsecured claims and Defendant shall receive nothing on account of any claim of Defendant filed in Debtor Northlake Foods, Inc.'s bankruptcy case, including without limitation Defendant's Proof of Claim No. 97 unless and until any and all allowed, non-insider, unsecured claims are paid in full.
