FINAL JUDGMENT

THIS MATTER came before the Court for purpose of entering a Final Judgment in favor of Plaintiff, Susan K. Woodard, as Chapter 7 Trustee of the estate of Synectic Asset Management, Inc. and against Defendant, Synectic Asset Ventures, LLC. The Court has considered the record and finds that this Court entered an Order Granting Corrected Motion to Compromise Adversary Proceeding 10-1352 [Doc. No. 123]. Based upon the Order, it is appropriate to enter this Final Judgment.

Accordingly, it is

ORDERED AND ADJUDGED that:

1. Final judgment is hereby entered in favor of the Plaintiff, SUSAN K. WOODARD, as Chapter 7 Trustee for SYNECTIC ASSET MANAGEMENT, INC., Post Office Box 7828, St. Petersburg, Florida 33734, and against Defendant, SYNECTIC ASSET VENTURES, LLC, 72 Greenridge Court, Lake Oswego, OR 97035, and SYNECTIC ASSET VENTURES, LLC, c/o Patti W. Halloran, Gibbons Neuman, 3321 Henderson Blvd., Tampa, FL 33609.

2. The Equity Interest, as defined in the Motion, is owned by SAM and is property of the SAM bankruptcy estate.

3. All distributions in kind or in cash by Fund III on account of the Equity Interest shall be made payable to Susan Woodard, as Trustee on behalf of the bankruptcy estate of Synectic Asset Management, Inc.


4. In the event that a Global Compromise, as amended, is fully funded on or before March 20, 2012, any amounts received by the Trustee on account of the Equity Interest will be credited towards the remaining financial obligations due under the Global Compromise, as amended.

5. The Court shall retain exclusive jurisdiction to interpret, enforce or otherwise implement the terms of the compromise.
