**ORDERED AND ADJUDGED** that:


1. Final judgment is hereby entered in favor of the Plaintiff, STEVEN S. OSCHER, as Chapter 11 Trustee for J.H. INVESTMENT SERVICES, INC. and DANIEL L. PREWITT, One Tampa City Center, 201 North Franklin Street, Suite 3150, Tampa, Florida 33602, and against Defendant, SEVEN STAR DISTRIBUTORS, INC. ("Distributors"), c/o its last President, Elizabeth George, 4942 Three Oaks Boulevard, Sarasota, Florida 34233 and against Defendant, SARAH L. PYLE, Neot Golf, Suite 105, Caesarea, Israel 30889.

2. The Court declares that the Challenged Transfers as defined in the Complaint herein comprised of three monetary transfers totaling \$14,420.00 to Distributors and Pyle are void, and Plaintiff, Steven S. Oscher is authorized to recover the amount of the Challenged Transfers from Distributors and Pyle, for which let execution issue, *forthwith and instanter*.

3. This Judgment shall be recorded in the public records and shall constitute a lien on property of Distributors and Pyle.
