JUDGMENT


This adversary proceeding came on for trial on March 26, 2007. In accordance with the findings of fact and conclusions of law stated orally and recorded in open court and pursuant to F.R.B.P. 7052, DECLARATORY JUDGMENT IS ENTERED AS FOLLOWS:

1. First: The Gateway Receivership Claim proceeds in the amount of \$14,770.52 shall be surcharged in the amount of \$3,500 to pay attorney's fees and costs incurred in recovering the asset.
2. Second: Ruth Riffel, n/k/a the Estate of Ruth Riffel, holds an equitable lien on that portion of the remaining Claim proceeds equal to the pro rata share (61.54%) of the Riffel contribution (\$100,000) to the total amount of the Gateway Claim filed by the Plaintiff/Trustee (\$162,500). The Riffel lien (\$6,935.70) shall attach to the proceeds and will be distributed to the Estate of Ruth Riffel upon the closing of the bankruptcy case.
3. Third: There were no equitable liens or other special interests in the funds demonstrated by Enrique Moreno, Mirtha Santos, or Nersa Bolsom.

4. Fourth: The remaining funds (\$4,334.82) are not subject to any equitable lien held by any defendant and are unencumbered property of the Bankruptcy Estate.
