FINAL JUDGMENT

THIS CAUSE came on for consideration by agreement for the parties, pursuant to Motion for Approval of Stipulation on Judgment with Respect to Debt filed by Creditor GTE FEDERAL CREDIT UNION [D.E.NO. 4].

Accordingly, it is hereby


ORDERED:

1. The Parties have entered into a Stipulation on Judgment, resolving all pending matters that are at issue in this adversary proceeding (D.E. 3).
2. Judgment is entered against Defendant LAURA JEANNE USHER in the amount of ONE THOUSAND THREE HUNDRED SEVEN AND 76/100 DOLLARS (\$1,307.76) as an exception to discharge.

3. Payments are due at the completion of the plan or dismissal of the case whichever occurs first.
4. Debtor shall pay Creditors attorney fees and costs in the amount of \$1,293 for the filing of this adversary action.
5. In the event that Defendants do not timely cure any missed payment, DEFENDANTS shall retain the debt at its full amount of ONE THOUSAND THREE HUNDRED SEVEN AND 76/100 DOLLARS (\$1,307.76) at the contractual rate of interest provided on the Defendants account held with Plaintiff, minus any amounts already paid by Defendants.
6. This default amount shall also be considered non-dischargeable upon the ex-parte filing of an Affidavit of Default with this Court and entry of an Amended Judgment.
