**FINAL JUDGMENT ON CONTINUING
WRIT OF GARNISHMENT POST JUDGMENT DIRECTED TO USSG REALTY,
LLC AND AGAINST SAM DAWKINS**

This case came on for hearing, on July 22, 2014, on the Motion (the “Motion”), by the Plaintiff, DEBORAH RASPA (“Ms. Raspa”), for a Final Summary Judgment on the Continuing Writ of Garnishment after judgment directed to USSG Realty, LLC (“USSG Realty”) and against Sam Dawkins (the “Defendant”) [Doc. No. 31]. As stated on the record, it is:

ORDERED:

1. The garnishee, USSG Realty, shall immediately pay to Ms. Raspa any amounts accumulated thus far from the withheld salary, wages, commissions or compensation earned by the Defendant since service of the Continuing Writ of Garnishment.
2. The payment by USSG Realty of any amounts thus far withheld from the

salary, wages, commissions or compensation earned by the Defendant since service of the Continuing Writ of Garnishment shall be immediately delivered to counsel for Ms. Raspa, Maureen A. Vitucci, Esq., at GrayRobinson, P.A, 301 E. Pine Street, Suite 1400, Orlando, FL 32801.

3. USSG Realty shall continue garnishing any salary, wages, commissions or compensation earned by the Defendant since service of the Continuing Writ of Garnishment with all payments to be delivered to counsel for Ms. Raspa, Maureen A. Vitucci, Esq., at GrayRobinson, P.A, 301 E. Pine Street, Suite 1400, Orlando, FL 32801 within five (5) days of paying the remaining salary, wages, commissions or compensation earned by the Defendant to the Defendant.


4. USSG Realty shall notify the Plaintiff if and when the Defendants is no longer employed by USSG Realty.

5. A judgment dissolving the writ of garnishment shall be entered after full payment to Plaintiff of the underlying judgment debt.

6. Due to the failure of USSG Realty to respond to the writ of garnishment, the Plaintiff, DEBORAH RASPA, Post Office Box 120896, W. Melbourne, Florida 32912 shall recover from the garnishee, USSG Realty, LLC d/b/a The United Short Sale Group, whose address is 9 East Lookerman St., Suite 3A, Dover, DE 19901 (FEIN 26-1939471), the

principal sum of **\$915,253.33**, which shall bear interest from the date of the judgment at the judgment rate of interest at 4.75% per annum initially and thereafter as provided by Section 55.03, *Florida Statutes*, for which sums let execution issue forthwith
