**CONSENT FINAL JUDGMENT**



Federal Highway, Suite 200, Fort Lauderdale, Florida 33316, and against Defendant, Sonshine Planning and Insurance Services, Inc. for the sum of \$94,482.47, that shall bear interest at the rate established by 28 U.S.C § 1961, for which let execution issue.

2. Pursuant to 11 U.S.C § 502(d), any claim filed by any Defendant shall be disallowed to the extent that such entity or transferee has not paid the amount, or turned over any such property, for which that entity or transferee is liable under 11 U.S.C. § 550.


