**FINAL DEFAULT JUDGMENT AGAINST DEFENDANTS
FINANCIAL PLUS, INC., FUN RECORDS, INC., AND ROSS DICKSON**

THIS CAUSE came before this Court on the Plaintiff's Motion for Final Judgment by Default Against Defendants Financial Plus, Inc., Fun Records, Inc., and Ross Dickson (the "Motion"; Dkt. No. 18). The Clerk of the Bankruptcy Court having entered a Default against all Defendants, and the Court having reviewed the Motion and accompanying Affidavit, and being otherwise fully informed in the premises, it is

ORDERED and ADJUDGED as follows:

1. Plaintiff, Soneet R. Kapila as Chapter 11 Trustee for the substantively

consolidated cases of Louis J. Pearlman shall recover from the Defendant, Financial Plus, Inc., whose registered agent's last known address is P.O. Box 3650, Seminole, Florida 33775-3650, the principal sum of \$438,013.17 plus pre-judgment interest in the amount of \$9,816.48 as of June 25, 2012, for a total of \$447,829.65, that shall bear interest at the rate of 28 U.S.C § 1961 for which let execution issue.

2. The Plaintiff, Soneet R. Kapila as Chapter 11 Trustee for the substantively consolidated cases of Louis J. Pearlman shall recover from the Defendant, Fun Records, Inc., whose registered agent's last known address is P.O. Box 3650, Seminole, Florida 33775-3650, the principal sum of \$2,392,309.83 plus pre-judgment interest in the amount of \$53,617.71 as of June 25, 2012, for a total of \$2,445,927.54 that shall bear interest at the rate of 28 U.S.C § 1961 for which let execution issue.

3. The Plaintiff, Soneet R. Kapila as Chapter 11 Trustee for the substantively consolidated cases of Louis J. Pearlman shall recover from the Defendant, Ross Dickson, whose last known address is P.O. Box 3650, Seminole, Florida 33775-3650, the principal sum of \$62,449.96 plus pre-judgment interest in the amount of \$1,400.79 as of June 25, 2012, for a total of \$63,850.75 that shall bear interest at the rate of 28 U.S.C § 1961 for which let execution issue.


4. Pursuant to 11 U.S.C § 502(d), any claim filed by any Defendant shall be disallowed to the extent that such entity or transferee has not paid the amount, or turned over any such property, for which that entity or transferee is liable under 11 U.S.C. § 550.
