FINAL DEFAULT JUDGMENT AGAINST AEGIS CONSULTING, INC.

THIS MATTER came before the Court upon the Trustee's Motion to Approve Compromise between Soneet R. Kapila, Chapter 11 Trustee for Trans Continental Airlines, Inc. and Louis J. Pearlman Enterprises, Inc., and Michael Crudele, Sheila Crudele and Aegis Consulting, Inc. (Dkt. No. 1546 in Case No. 6:07-bk-00761-ABB; the "Motion") and the Order granting the Motion entered on January 20, 2009 (Dkt. No. 1599 in Case No. 6:07-bk-00761-ABB; the "Order"). The Court, having approved the terms of the compromise between the Trustee and the Defendants (the "Compromise") as

set forth in the Order, and determining that pursuant to the Compromise the parties have agreed that a Final Default Judgment shall be entered against Defendant, Aegis Consulting, Inc. ("Aegis") upon entry of the Order, it is

ORDERED AND ADJUDGED:

1. A Final Default Judgment is entered in favor of Plaintiff, Soneet R. Kapila, as Chapter 11 Trustee for the bankruptcy estates of Trans Continental Airlines, Inc. and Louis J. Pearlman Enterprises, Inc., against Defendant, Aegis, on Counts V through VIII and XI through XIV of the Amended Complaint to Avoid and Recover Fraudulent Transfers, for Damages, for Injunctive Relief and for Other Relief (Dkt. No. 8).

2. Plaintiff shall have and recover from Defendant, Aegis, the amount of \$5,107,143.15, plus taxable costs and post-judgment interest, for which sums let execution issue.
