
ORDERED AND ADJUDGED:

1. The claim of Chiu Associates, LP against Yasuhiko Tominaga as evidenced by the Proof of Claim filed in the Debtor's case number 6:04-bk-08527-KSJ is hereby determined to be an exception to discharge pursuant to 11 U.S.C. §523(a)(2)(A) and (a)(6) and is in full force and effect, as set forth herein.

2. Plaintiff, Chiu Associates, LP, shall recover from and against Yasuhiko Tominaga the sum of Two Hundred Twenty Nine Thousand and Two Hundred Dollars (\$229,200.00), plus pre-judgment interest at the contract rate of 6% through the date of this judgment plus interest therein at the federal judgment rate for all which let execution issue.

3. The Court retains jurisdiction for any post-judgment proceedings.
