DEFAULT FINAL JUDGMENT AGAINST DEFENDANT MOBISSIMO, INC.

THIS PROCEEDING came before the Court without hearing on the Plaintiff's Motion for Entry of Default Final Judgment Against Defendant Mobissimo, Inc. [Dkt. No. 7] filed by Plaintiff Lauren P. Greene, Chapter 7 Trustee for the estates of 1800Hotels4U, LLC, d/b/a 1800Hotels.com and Happy Duck Limited ("Plaintiff"). Upon consideration of the record of this adversary proceeding, including the Clerk's Default entered against Defendant Mobissimo, Inc. ("Defendant") on October 1, 2012 (Dkt. No. 5) as a result of the Defendant's failure to answer or otherwise respond to the Complaint as required by Rule 7012 of the Federal Rules of Bankruptcy Procedure, the Court determines that Plaintiff is entitled to entry of a Default Final Judgment against

the Defendant on all counts of the Complaint as a matter of law pursuant to Rule 55(b)(2) of the Federal Rules of Civil Procedure, as incorporated into Rule 7055 of the Federal Rules of Bankruptcy Procedure. Accordingly, it is

ORDERED:

1. A Default Final Judgment is hereby entered against Defendant and in favor of Plaintiff in the sum of \$30,000.00, with post-judgment interest accruing at .19 % as of the date of this Default Final Judgment, *for which let execution issue.*


