PREWITT, One Tampa City Center, 201 North Franklin Street, Suite 3150, Tampa, Florida 33602, and against Defendants, COMBINED CARPENTRY SERVICES, INC., 705 South Lockwood Ridge Road, Sarasota, FL 34237; and FRANK DICOSTANZO, 705 South Lockwood Ridge Road, Sarasota, FL 34237, jointly and severally in the principal amount of \$120,000, plus court costs in the amount of \$250.00, which sum shall hereafter draw interest at the allowable daily rate ^{at 3.3%} pursuant to 28 U.S.C. kan 1961, for which let execution issue forthwith.
