CONSENT FINAL JUDGMENT

This adversary proceeding came before the Court, on March 18, 2014, on the Motion for Summary Final Judgment (the "Motion") [Doc. No. 11] filed by Deborah Raspa ("Ms. Raspa") and against Sam Dawkins (the "Debtor"). Based on the allegations in the Motion for Summary Judgment along with the Affidavit of Ms. Raspa, and based on the Order Granting Compromise of Controversy [Main Case Doc. No. 25] and the approved Stipulation of Settlement [Doc. No. 22] between Ms. Raspa and the Debtor, it is;

ORDERED AND ADJUDGED as follows:


1. The Plaintiff, DEBORAH RASPA ("Ms. Raspa"), Post Office Box 120896, W. Melbourne, Florida 32912 shall recover from the Defendant, SAM DAWKINS (the "Debtor"), whose address is 1537 Wacker Avenue, Palm Bay, Florida 32909, the principal sum in the amount of \$260,530.00, additional treble damages in the amount of \$521,060.00, prejudgment interest in the amount of \$111,376.58, attorneys' fees in the amount of \$20,511.50 and court

costs in the amount of \$1,775.25, for a total of \$915,253.33 (the "Judgment Debt"), which shall bear interest from the date of the judgment at the judgment rate of interest at 4.75% per annum initially and thereafter as provided by Section 55.03, *Florida Statutes*, for which sums let execution issue forthwith

3. The Judgment Debt has been adjudicated to be non-dischargeable pursuant to Bankruptcy Code § 523(a)(2), § 523(a)(4) and 523(a)(6) by separate Order of this Court.

4. This Court hereby reserves jurisdiction to enforce this Judgment, for which let execution issue.
