FINAL JUDGMENT

This matter came for consideration before this Court, the Honorable Michael G. Williamson, United States Bankruptcy Judge, presiding, this Court having considered the Motion to Compromise Controversy (Doc. 267), Order Granting Motion to Compromise Controversy (Doc. 284), Motion to Compel Compliance with Motion to Compromise Controversy and Settlement Agreement (Doc. 322), the Court having heard argument from counsel for the Trustee and from counsel for Melton Frahmman, Carol Frahmman and Garrett Bell, the Court having taken note that Melton Frahmman, Carol Frahmman and Garrett Bell entered into a Settlement Agreement, which was later approved by this Court, this Court having noted that the financial payment obligations owed by such persons have not been met, and this Court being otherwise fully advised in the premises, and a decision having been duly rendered,

It is hereby ORDERED and ADJUDGED that:

Angela Welch Esposito, the Chapter 7 Trustee of this bankruptcy estate (“Trustee”), has and hereby recovers a Final Judgment jointly and severally against Melton Frahmman, Carol Frahmman and Garrett Bell (“Defendants”), the sum of \$15,000.00, along with interest at the rate of 4.98% per annum, fees and costs from June

16, 2007, ~~until paid~~ for all of which let execution issue. This Judgment shall continue to bear interest from the date of entry of this Judgment at the rate of 1.44% per annum, as provided for by applicable Federal law, until satisfied. This Court will retain jurisdiction over the enforcement of this Final Judgment.
