**FINAL JUDGMENT**

THIS CAUSE coming to be considered on the Ex Parte Motion for Final Judgment and the Court having reviewed the Motion, the Settlement Agreement entered into by the parties dated August 3, 2006, and this Court's previous Final Judgment dated August 23, 2006, and having reviewed the Affidavit of counsel as to the default and amount owed, and the Court being otherwise duly advised in the premises, it is thereupon ORDERED and ADJUDGED as follows:

1. Plaintiff, AMSOUTH BANK, whose address is 13535 Feather Sound Drive, Suite 510, Clearwater, FL 33762 is entitled to, and this Court does hereby enter, a Final Judgment against Defendants, SHELTON ALLEN THORNE, DONNA K. THORNE, AMERICAN TRAVEL CORPORATION, and COVENANT BUSINESS CONSULTANTS OF FLORIDA, INC., jointly and severally in the amount of Fifty-Six Thousand, Six Hundred Sixty-Six Dollars and Sixty-One Cents (\$56,666.61), representing the amount owed plus prejudgment interest calculated in accordance with the stipulation of Thirty-Eight Thousand, Nine Hundred Fourteen Dollars and Forty-Eight Cents (\$38,914.48), plus attorney's fees in the amount of Twelve Thousand Fifty-One Dollars

(\$12,051.00), plus costs of Five Thousand, Seven Hundred One Dollar and Thirteen Cents (\$5,701.13) incurred from July 2, 2004, and plus interest from the date of this Judgment at the rate of eighteen percent (18%), as the post-judgment interest rate as stipulated to in the Settlement Agreement, all for which sums let execution issue forthwith.
