**FINAL JUDGMENT
ON CASTLEGARDE, INC.'S NON-DISCHARGEABILITY
CLAIMS AGAINST DANIEL M. JUNEAU AND RICK L. WOODS**

THIS PROCEEDING came to be heard pursuant to the Order Finding Debt of Daniel M. Juneau & Rick L. Woods to Castlegarde, Inc. to be Non-Dischargeable dated May 27, 2011 (Doc 117) and this Court's Order Determining Damages on Complaints for Non-Dischargeability dated January 10, 2011(Doc 156), it is therefore ORDERED and ADJUDGED:

1. Castlegarde, Inc¹ shall have and recover judgment against the Defendant Rick L. Woods the sum of One Hundred Three Thousand Nine Hundred Fifty Dollars (\$103,950.00) plus prejudgment interest at the rate of 4.5% per annum from December 2, 2006 to date in the amount of Twenty Three Thousand Five Hundred Ninety Dollars and Thirty-Five Cents (\$23,590.35) for an aggregate total of One Hundred Twenty Seven Thousand Five Hundred Forty Dollars and Thirty-Five

Cents (\$127,540.35), plus interest hereafter at the statutory rate, for all of which let execution issue.

2. The amount of damages determined by this Court shall be set off with respect to Daniel M. Juneau in the amount of Fifty Thousand Dollars (\$50,000.00) in accordance with the prior agreement of the parties (See, Doc 119) for a net total of Fifty Three Thousand Nine Hundred Fifty Dollars (\$53,950.00). Castlegarde, Inc.² shall therefore have and recover judgment against the Defendant Daniel M. Juneau for the sum of Fifty Three Thousand Nine Hundred Fifty Dollars (\$53,950.00), plus prejudgment interest at the rate of 4.5% per annum from December 2, 2006 to date in the amount of Twelve Thousand Two Hundred Seventy-One Dollars and Seventy-Eight Cents (\$12,271.78), for an aggregate total of Sixty-Six Thousand Two Hundred Twenty-One Dollars and Seventy-Eight Cents (\$66,221.78), plus interest hereafter at the statutory rate, all for which let execution issue.

3. The judgments above are joint and several.

4. The Court reserves jurisdiction to award attorney's fees and costs in connection with these proceedings and the related state court proceedings.


