
FINAL JUDGMENT

This matter came before the Court upon the Motion for Entry of Default Final Judgment (the “**Motion**”) filed by Plaintiff, Steven S. Oscher, as the Chapter 7 Trustee for United Container, LLC (the “**Chapter 7 Trustee**”), whose mailing address is 100 South Ashley Drive, Suite 2060, Tampa, FL 33602. The Court, having granted the Motion in its entirety, having heard argument from counsel, and having found in favor of Plaintiff, hereby orders and adjudges as follows:

ORDERED AND ADJUDGED that the Chapter 7 Trustee, Steven S. Oscher, shall recover from Defendants, Sanchez Trucking, Inc., Sanchez Truck Services, Inc., Sanchez Transport Services, Inc., Sanchez Truck Brothers, Inc., Sanchez Truck Brokerage of Polk

County, Inc., and Beverage Transport, Inc., damages in the principal amount of \$6,573,548.64, plus pre-judgment interest in the amount of \$392,188.23 (calculated using average of monthly U.S. Government Securities Treasury Constant Maturities Rates from 12/3/05-1/31/06), for a total of **\$6,965,736.87**, all of which shall bear interest at the statutory rate of 4.50% per annum (compounded annually) as provided by 28 U.S.C. § 1961, for all of which **LET EXECUTION ISSUE.**
