AGREED JUDGMENT OF NON-DISCHARGEABILITY OF DEBT

THIS CAUSE having come before the Court upon the Settlement Stipulation dated April 28, 2011 (“Settlement Stipulation”) [Doc 11] pursuant to which the parties requested Court approval of the Settlement Stipulation and entry of this Agreed Judgment, and the Court being advised at a pre-trial conference that a resolution was reached, and after reviewing the Court file and being fully advised in the premises, it is:

ORDERED AND ADJUDGED as follows:

1. The Settlement Stipulation is hereby approved in its entirety.
2. Defendant Cleveland Arthur Payne (“Payne”) is indebted to Automotive Finance Corporation (“AFC”) in the amount of Seventy-Eight Thousand Six Hundred and

Twenty Three Dollars and 53/100 Dollars (\$78,623.53).

3. **Payne agrees to entry of a judgment (the “Judgment”), and judgment be and hereby is entered in the amount of Seventy-Eight Thousand Six Hundred and Twenty Three Dollars and 53/100 Dollars (\$78,623.53) against Payne and in favor of AFC in this adversary proceeding.**
4. AFC and Payne stipulate and agree that the Judgment is a nondischargeable debt of Payne’s pursuant to 11 U.S.C. §§ 523(a)(2)(A), 523(a)(4), and 523(a)(6) and shall be entitled to collateral estoppel effect in this and any subsequent bankruptcy case filed by or against Payne.
