JUDGMENT

THIS CAUSE came before the Court, upon the Parties' Joint Stipulation in Compromise of Complaint to Determine Dischargeability of Debt and Motion to Approve Compromise of Controversy. The Court having granted the Motion and approved the Compromise for the stated orally on the record, it is therefore


ORDERED, ADJUDGED AND DECREED that

1. Judgment is entered in favor of Plaintiff, SUNCOAST SCHOOLS FEDERAL CREDIT UNION, and against Defendants/Debtors, DESIMENE PIERRE JANVIER, and PIERRE REYNOLD JANVIER, determining the debt to Plaintiff in the amount of \$11,906.36 to be excepted from discharge pursuant to 11 U.S.C. § 523(a)(2)(A). Interest shall accrue on said indebtedness at the rate provided for in the parties' credit card agreement.

2. Plaintiff shall not seek to collect on this Judgment so long as Defendants/Debtors comply with the terms and conditions of the Joint Stipulation. Any payments required by the Joint Stipulation shall be made payable to Suncoast Schools Federal Credit Union and delivered to the following address: Suncoast Schools Federal Credit Union, c/o Bankruptcy Department, P.O. Box 11904, Tampa, FL 33680.

3. Should Defendants/Debtors fail to comply with the terms and conditions of the Joint Stipulation, upon presentation of an Affidavit of Default, the Clerk is directed to issue, without further notice to Defendant, a Writ of Execution in accordance with Rule 7069, Federal Rules of Bankruptcy Procedure, for the amount of this Final Judgment, less any payments made under paragraph 2, above.
