Tang, to Plaintiff, American Express Centurion Bank on credit card Account No. xxxx-xxxxxx-x1008, in the amount of \$13,493.72, plus costs of \$250.00, for a total of \$13,743.72 ("Judgment Amount"), plus interest, is non-dischargeable and shall survive and be excepted from any discharge granted to the Defendant, Cindy Thi Tang a/k/a Cindy T. Tang, in her Chapter 13 bankruptcy case, No. 8:11-bk-06604-KRM.

2. Plaintiff, American Express Centurion Bank, shall recover from the Defendant, Cindy Thi Tang a/k/a Cindy T. Tang, the Settlement Amount of \$6,000.00, as set forth in the Stipulation in Settlement of Adversary Proceeding.

3. Said Settlement amount shall not be subject to discharge in the Chapter 13 case.
