1. Shumaker, Loop & Kendrick, LLP and Steven N. Berman, Esq., as counsel for the Defendant, Douglas N. Menchise, shall recover from Terri L. Steffen and David E. Hammer, jointly and severally, the principal amount of **Five Thousand and 00/100 Dollars (\$5,000.00)**, which shall bear interest at the current statutory rate, for all of which let execution issue forthwith.

2. The relief afforded herein is in addition to any relief afforded by the United States District Court for the Middle District of Florida or other Court.


3. This Court shall retain such other and further jurisdiction as may be necessary to implement the effect of this Order
