FINAL JUDGMENT BY CONSENT

This adversary proceeding came on for consideration before the Court, the undersigned United States Bankruptcy Judge presiding, for the entry of a Judgment pursuant to the Court's Order Granting Motion for Approval of Joint Stipulation for Entry of Judgment in Settlement of Complaint to Determine Dischargeability of Debt. The issues having been duly considered and a decision having been duly rendered,

IT IS ORDERED AND ADJUDGED:

1. Judgment in the above matter shall be entered by the United States Bankruptcy Court against the Defendants and in favor of the Plaintiff in the principle amount of \$8,379.56, plus costs and post-judgments interest thereon from the date of entry of Judgment at the maximum rate provided by Federal law ("Judgment Amount"). The Judgment Amount is nondischargeable pursuant to 11 U.S.C. §523(a)(2)(A) and shall survive and be excepted from any discharge granted to the Defendants in their Chapter 7 Bankruptcy Case, No. 8:11-bk-12731-CPM.

2. The Defendants may satisfy the Judgment Amount pursuant to the terms and conditions of the Joint Stipulation; and

3. The Clerk shall mark the above-captioned adversary proceeding as CLOSED, subject to the terms and conditions of the Joint Stipulation.
