JUDGMENT AGAINST DEFENDANT JOHN P. LEWIS

This judgment is entered after Order Granting Motion for Approval of Stipulation for Judgment. It is

ORDERED, ADJUDGED AND DECREED that judgment is hereby entered in favor of Plaintiff and against Defendant for the principal sum of \$12,185.75 together with interest at the statutory rate per annum from and after January 29, 2008 together with the costs of this action.



FURTHER ORDERED, ADJUDGED AND DECREED that the judgment is nondischargeable pursuant to 11 U.S.C. Section 523(a)(2)(A) and Section 523(a)(2)(C) of the United State Bankruptcy Code, and it is:

FURTHER ORDERED, ADJUDGED AND DECREED that execution on the judgment shall be stayed against Defendant provided that Defendant pays the sum of \$50.00 due on July 15, 2008 and then pays \$50.00 on or before the 15th day of each month for a total of 12 months. Then on or before July 15, 2009 the payment amount shall increase to \$100.00 and Defendant shall continue to make \$100.00 payment on the 15th of each month until such time as \$6,500.00 has been paid. As long as timely payments are made, the payments shall apply to the sum \$6,500.00 of and all interest plus remaining principal shall be waived. Should Debtor default in any provision of this Agreement or default in the repayment of the debt at any time, then the full amount of the judgment, \$12,185.75 including all interest at the statutory rate per annum from and after January 29, 2008, plus attorneys fees shall become immediately due and owing, and
