FINAL GARNISHMENT JUDGMENT

2. That the Garnishee, Washington Mutual Bank, be, and the same is hereby directed to pay within thirty (30) days from date hereof the sum of \$209.33 to the order of Steven S. Oscher as Chapter 11 Trustee for J.H. Investment Services, Inc., c/o Stephanie Crane Lieb, attorney for Plaintiff, Trenam, Kemker, Scharf, Barkin, Frye, O'Neill & Mullis, P.A., Post Office Box 1102, Tampa, Florida 33602.

3. A reasonable attorney's fee is taxed in this cause in the amount of \$100.00, and the Plaintiff is directed to remit said amount of the fee to Maxine M. Long, attorney for JP Morgan Chase and Washington Mutual Bank, Shutts & Bowen LLP, 1500 Miami Center, 201 South Biscayne Boulevard, Miami, Florida 33131.
