**FINAL JUDGMENT IN FAVOR OF PLAINTIFF, CALYON
CORPORATE AND INVESTMENT BANK, AND AGAINST
DEFENDANT, GENCOR INDUSTRIES, INC.**

THIS CAUSE came before the Court on Plaintiff's Motion for Entry of Final Judgment (Dkt. No. 47; the "Motion"). The Court, having considered the Motion, finding that Plaintiff is entitled to a Final Judgment pursuant to this Court's *Order Granting Plaintiff's Motion for Summary Judgment and Denying Defendant's Motion for Summary Judgment* dated May 18, 2007 (Dkt. No. 30), having reviewed the fees and costs sought by Plaintiff in the Anderson Affidavit (Dkt. No. 39), the Akerman Affidavit (Dkt. No. 40), the Second Anderson Affidavit (Dkt. No. 45), and the Second Akerman Affidavit

(Dkt. No. 46),¹ and having determined that these fees and costs are reasonable, noting that Defendant, Gencor Industries, Inc., filed a Notice of Non-Opposition to Plaintiff's Motion for Entry of Final Judgment (Dkt. No. 48), and being otherwise duly advised in the premises, it is

ORDERED AND ADJUDGED:

1. Plaintiff's Motion for Entry of Final Judgment is hereby **GRANTED**.
2. Plaintiff, Calyon Corporate and Investment Bank, shall have, receive and recover from Defendant, Gencor Industries, Inc., the amount of \$129,720.37, for which sum let execution issue forthwith.
