JUDGMENT

THIS CAUSE having come before the Court for trial on September 6, 2006, upon Plaintiff's Amended Complaint (Doc. No. 23) against Defendant, DAKA DEVELOPMENT, LTD. The Court having entered its Order thereon, hereby renders its Judgment as follows:

It is **ORDERED** that:

1. Plaintiff, Michael Moecker, as Liquidating Trustee for Lentek International, Inc., shall have and recover from Defendant, DAKA DEVELOPMENT, LTD., the total sum of \$1,148,217.91, consisting of the principal amount of \$988,232.43 together with taxable costs of \$3,849.72 and prejudgment interest at the rate of 5.03% per annum from the date of payment of the unauthorized pre-petition and post-petition transfers through the date of trial in the amount of \$156,135.76 calculated as follows:
