
ORDERED:

1. Final Judgment is entered on Count I of the Complaint in favor of the Plaintiff and against the Defendant in the amount of \$30,597.01.

2. The writ of garnishment is avoided as a preference pursuant to 11 U.S.C. §547.

3. Bank of America, N.A. (the Garnishee) is hereby authorized and directed to immediately turnover the amount of \$30,597.01 garnished from the account of the Debtor (Account No. xxxxxxxx2523) to Stephen L. Meininger, the Chapter 7 Trustee.
