DEFAULT FINAL JUDGMENT

THIS MATTER came before the court upon Plaintiff, Mariaelena Gayo-Guitian's Motion for Entry of Final Judgment by Default Against Defendant, Attaway Services, Inc. (the "Motion")[CP #7]. The Court having noted that a clerk's default has been entered against Defendant, and being otherwise duly advised in the premises, it is hereby:

ORDERED and ADJUDGED as follows:

1. Final Judgment is entered in favor of the Plaintiff, MARIAELENA GAYO-GUITIAN, as the Liquidating Trustee of the Apache Products Liquidating Trust, and against the Defendant, ATTAWAY SERVICES, INC. in the amount of Eight Thousand Five Hundred Dollars (\$8,500.00), which represents the transfers made to the Defendant based upon the undisputed allegations in the Preference Adversary Proceeding filed herein.


2. The Plaintiff shall have and recover from Defendant, the sum of Eight Thousand Five Hundred Dollars (\$8,500.00), which shall accrue interest at the legal rate of six percent (6%) per annum for which let execution issue.
