FINAL JUDGMENT

This matter came before the Court on the Complaint filed by the Plaintiff, **NILA SHAFER**, under 11 U.S.C. § 523 (a) (5) and (a)(15). The parties previously having entered into a Joint Stipulation, and the Court having entered an Order Approving the Stipulation entered into by parties, finds as follows:

1. Plaintiff filed this adversary proceeding on May 20, 2005.
2. The parties entered into a Joint Stipulation in open Court on July 10, 2006.
3. The Defendant was obligated to pay the settlement amount of \$38,000.00 within 90 days of the execution of the Joint Stipulation.
4. The Defendant did not comply. He made two payments of \$1,000.00 each for a total of \$2,000.00.
5. The Plaintiff filed an Affidavit of Default in payments.

6. Under the terms of the stipulation, if the Defendant defaulted in payments, Judgment would be entered against him for the full amount of relief sought in the Complaint, and the obligation would be in the nature of support, under 11 U.S.C. § 523 (a) (5).
7. In addition, the Defendant agreed not file any Chapter of Bankruptcy in an attempt to discharge or reorganize the debt owed to the Plaintiff.
8. Based upon the above findings, Judgment is hereby entered in favor of the Plaintiff against the Defendant in the amount of \$51,552.99, plus an additional \$750.00 for a total of \$52,302.99. This obligation shall be non-dischargeable and in the nature of support pursuant to 11 U.S.C. § 523 (a) (5). It may not be discharged or reorganized under any chapter of bankruptcy.


