**FINAL DEFAULT JUDGMENT**

The Matter under consideration is the entry of final default judgment in favor of Plaintiff, Angela Welch Esposito, as Trustee for the Hydro Spa Parts and Accessories, Inc. Liquidating Trust (the “**Trustee**”) and against the Defendant, Southland Home Products, Inc. The Court considered the record and finds that the Court has granted the Trustee’s Motion for Final Default Judgment as to the Defendant. Therefore, the Court finds that it is appropriate to enter a final default judgment in favor of the Trustee and against the Defendant. Accordingly, it is

ORDERED and ADJUDGED that:

1. Final Default Judgment is hereby entered in favor of the Plaintiff, Angela Welch Esposito, as Trustee for the Hydro Spa Parts and Accessories, Inc. Liquidating Trust (the “**Trustee**”) and against the Defendant, Southland Home Products, Inc. (“**Defendant**”).
2. The following transfers to Defendant evidenced by checks drawn on the Debtor’s bank account at Bank of America, account number 5566395322 are declared to constitute avoidable transfers under the Bankruptcy Code pursuant to Sections 547 and 550 of the Bankruptcy Code:
  - a. The transfer evidenced by Check No. 41176 dated June 15, 2007 in the amount of \$9,923;
  - b. The transfer evidenced by a Check No. 41344 dated June 21, 2007 in the amount of \$1,380; and,
  - c. The transfer evidenced by Check No. 41887 dated August 15, 2007 in the amount of \$1,550; and,
  - d. The transfer evidenced by Check No. 41942 dated August 23, 2007 in the amount of \$1,991.25;
3. The address of the Trustee is Post Office Box 549, Odessa, FL 33556-0549.
4. The last known address for the Defendant is Southland Home Products, Inc., c/o **Don Lucas, Manager**, 6419 N. 50th Street, Tampa FL 33610 and Southland Home Products, Inc. c/o **Kevin M. Kenney**, Registered Agent, 101 E. Kennedy Blvd., Suite 3200, Tampa, FL 33602.

5. Plaintiff shall recover from Defendant, the principal sum of \$14,844.25, plus interest from April 13, 2009 through March 1, 2010 in the amount of \$79.42, for a total of \$14,923.67 which sum shall bear interest at .26%, the federal rate of interest, from the date of this Judgment until same is paid as provided by 28 U.S.C.A. § 1961(A), for which sum let execution issue.
