
ORDERED, ADJUDGED and DECREED that:

1. Final Judgment is hereby entered against Defendant Theresa Nassif in the sum of \$817,514.33, the amount of Merrill Lynch's damages set forth in the Complaint (at, *e.g.*, pages 5, 14-16 and Exhibit L), with post-judgment interest at the post-judgment rate provided by 28 U.S.C. § 1961, for all of which let execution issue forthwith.

3. Jurisdiction is retained to enter further Orders as are appropriate, including but not limited to Orders to enforce this Judgment.


