C. That Plaintiff JOSEPH A. DELELLIS, JR. is entitled to execution thereon.


NOW, THEREFORE, IT IS ORDERED AND ADJUDGED:

**J.B. VOL. 16 NO. 1130**

1. That Judgment for JOSEPH A. DELELLIS, JR. is to be recovered from Defendant SANJEEV SINGH, Social Security Number XXX-XX-2710 residing at 125 W. GADSEN LANE, COCOA BEACH FL 32931, in the amount of \$300,000.00, plus statutory interest, against SANJEEV SINGH, for which execution may issue for enforcement and collection of the debt, and the Plaintiff shall have the right of all legal process for the full satisfaction and enforcement thereof.

2. Defendant SANJEEV SINGH shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on the judgment creditor's attorney, Jason M Gordon, Esquire, 257 North Orlando Avenue, Cocoa Beach, FL 32931, within 45 days from the date of this final judgment, unless the final judgment is satisfied or post-judgment discovery is stayed. Jurisdiction of this case is retained to enter further orders that are proper to compel the judgment debtor(s) to complete form 1.977, including all required attachments, and serve it on the judgment creditor's attorney or the judgment creditor if the judgment creditor is not represented by an attorney.
