ORDERED:

1. Judgment is entered in favor of Plaintiff, Gordon P. Jones, as Chapter 7 Trustee of the Bankruptcy Estate of Ann Marie Lafrentz, and against Defendant, Brandon Woods.


2. The Debtor's wedding ring (the "Wedding Ring"), which is referred to in Paragraph 26 of the consent final judgment of dissolution of marriage entered on August 23, 2007 in the divorce case styled as In re: The Marriage of Brandon Woods, Husband, and Ann

Woods, Wife; In the Circuit Court, Fourth Judicial Circuit, In and for Duval County, Florida;

Case No. 06-DR-6998, Div. FM-C, is property of the Bankruptcy Estate.

3. Defendant is directed to turnover the Wedding Ring to Plaintiff within thirty (30) days of the date of this Judgment. If Defendant is not in possession of the Wedding Ring, or does not turnover the Wedding Ring to Plaintiff within thirty (30) days of the date of entry of this Judgment, Defendant is directed to pay to Plaintiff \$8,500, which is the value of the Wedding Ring, plus interest at the legal rate of 0.27 % from the date of this Judgment and Court costs in the amount of \$250.00, for all of which let execution issue.
