



JUDGMENT


This proceeding is before the Court upon the adversary complaint to modify the Berenice E. Timmerman Trust, filed by plaintiff, Alexander G. Smith, as Chapter 7 Trustee, against defendants, Marian Dietrich, as Trustee of the Berenice E. Timmerman Trust (the "Trust"), William H. Timmerman and Rachel Louise Timmerman. Based upon the consent of the plaintiff and defendants, it is

ORDERED:

1. Judgment is entered in favor of plaintiff, Alexander G. Smith, as Chapter 7 Trustee of the bankruptcy estate of William H. Timmerman and Shelly A. Timmerman.

2. The Berenice E. Timmerman Trust is hereby modified to allow Marian Dietrich, as trustee of the Trust, to immediately distribute to plaintiff \$33,000 of the Trust's assets in full satisfaction of the bankruptcy estate's interest in the Trust (except for the \$6,000 which the bankruptcy estate has already received from the Trust) including, without limitation, the bankruptcy estate's entitlement, pursuant to this Court's order sustaining in part and overruling in part trustee's objection to debtors' claim of exemption, to (i) 25% of the balance of the Trust assets which must be turned over to the plaintiff when William H. Timmerman attains the age of 55 and (ii) 25% of all monthly distributions by the Trust to Mr. Timmerman beginning April 2006 and continuing each month thereafter.
