1. Consistent with the rulings in the Clerk's Default and the Order Granting Motion for Default, which were entered in favor of the Plaintiff, Final Judgment is hereby entered against Enterprise Construction, Inc., in favor of the Plaintiff in the amount of \$35,012.31, plus interest from July 20, 2009, through judgment at the applicable statutory rate of interest on Count IV of the Complaint, plus post-judgment interest at the applicable statutory rate; and

2. This Court shall retain such other and further jurisdiction as may be necessary to implement the effect of this Order.
