FINAL JUDGMENT


THIS CASE came to trial on June 11, 2013 on the Complaint to Determine Dischargeability of Debt Owed by Rigoberto Sotolongo. The issues having been tried, the Court rendered its oral ruling on July 25, 2013. Pursuant to the oral findings of fact and conclusions of law stated on the record,

IT IS ORDERED AND ADJUDGED that:

1. Judgment is entered in favor of the Plaintiff American Airlines, Inc.
2. The debt of \$4,000,000.00 owed by Rigoberto Sotolongo as set forth in the Judgment in a Civil Case entered April 5, 2011 in the matter styled American Airlines, Inc. v. In Charge Marketing, Inc., Peter Sotolongo, also known as Pedro Sotolongo, Rogoberto Sotolongo, Peter Nagy, Jr., Daniel Marshall, Case No. 2:10-cv-467-FtM-29SPC in the United States District Court for the Middle District of Florida (the "District Court Judgment") is excepted from discharge pursuant to 11 U.S.C. § 727(a)(4).

3. The prospective permanent injunction entered in the District Court Judgment is excepted from discharge pursuant to 11 U.S.C. § 727(a)(4).
