IT IS ORDERED AND ADJUDGED:

1. Judgment in the above matter is hereby entered against the Defendants and in favor of the Plaintiff in the principle amount of \$8,903.78, plus reasonable attorneys' fees, costs, and post-judgments interest thereon from the date of entry of Judgment at the of 0.27%, as provided by Federal law ("Judgment Amount"). The Judgment Amount is nondischargeable pursuant to 11 U.S.C. §523(a)(2)(A) and \$5,176.65 of the Judgment Amount is nondischargeable pursuant to

11 U.S.C. §523 (a)(14A), for a total Judgment Amount of \$8,903.78, and shall survive and be excepted from any discharge granted to the Defendants in their Chapter 7 Bankruptcy Case, No. 8-10-BK-17075-CPM.

2. The Defendants may satisfy the Judgment pursuant to the terms and conditions of the Joint Stipulation; and

3. The Clerk shall mark the above-captioned adversary proceeding as CLOSED, subject to the terms and conditions of the Joint Stipulation.
