**DEFAULT FINAL JUDGMENT**

THIS MATTER came before the court upon Plaintiff's, Mariaelena Gayo-Guitian, as the Liquidating Trustee of the Apache Products Liquidating Trust ("Liquidating Trustee" or Plaintiff") Motion for Final Judgment by Default against Defendant, DREW FOAM COMPANIES, INC. ("DREW FOAM" or "Defendant"). The Court, having reviewed the pleadings and papers herein, and being otherwise duly advised of the premises, it is


ORDER as follows:

1. Service of Process was effected upon Drew Foam on January 27, 2005. [CP 3].
2. Defendant has failed to file any responsive pleading within the time provided by law. Therefore, a Clerk's Default has been entered by the Clerk of the Court pursuant to Fed.R.Bank.P.7055 on April 26, 2006. [CP #5].
3. The Court has jurisdiction of the parties and subject matter of this cause.

4. The Plaintiff is entitled to a Default Final Judgment in the amount of **\$14,525.44** which represents the transfers made to the Defendant based upon the undisputed allegations in the Preference Adversary Proceeding filed herein. The total amount shall bear interest at the rate of 6% per annum until paid in full, for all of which let execution issue forthwith.

5. This Court shall retain jurisdiction to enforce this Default Final Judgment.
