**STIPULATED FINAL JUDGMENT**


THIS MATTER came before the Court on the Complaint Seeking Exception to Discharge of Debtor in the amount of \$120,000.00. The Complaint has four Counts as follows: Count I: § 523(a)(2)(A); Count II: § 523(a)(4); Count III: § 523(a)(6); and Count IV: § 523(a)(19). The Debtor, Terrence Reid Pipenhagen, stipulated to a Final Judgment in the amount of \$120,000.00 on Count I under § 523(a)(2)(A) at the Pre-Trial Conference held on November 29, 2007. Count II, Count III and Count IV will be dismissed. Accordingly, it is

ORDERED, ADJUDGED AND DECREED that Judgment is entered for the Plaintiffs, Rusty Zimmerman and Debra Zimmerman, in the amount of \$120,000.00 against the Debtor, Terrence Reid Pipenhagen; and it is further

ORDERED, ADJUDGED AND DECREED that Count II, Count III and Count IV are dismissed; and it is further

ORDERED, ADJUDGED AND DECREED that for the sum of \$120,000.00 let execution issue and the Court does not reserve jurisdiction and the adversary proceeding shall be closed.
