JUDGMENT


THIS CAUSE came on for consideration, ex parte, for entry of a Judgment in the above captioned adversary proceeding. The Court has considered the record and finds that the Debtor entered into a Stipulation (Doc # 10) with the Plaintiff, thereby consenting to the entry of a Judgment under certain conditions set forth in the Stipulation. Based on the Stipulation,

Accordingly, it is

1. The debt owed by Defendants, Fred X. Rescigno Sr., a/k/a Frederick Xavier Rescigno and Diane B. Rescigno a/k/a Barbara Dianne Rescigno, to Plaintiff, American Express Centurion Bank, on credit card Account No. xxxx-xxxxxx-x3009 in the amount of \$7,104.62, plus costs of \$250.00 and interest at the Federal rate, is non-dischargeable and shall be excepted from any discharge granted to Defendants, Fred X. Rescigno Sr., a/k/a Frederick Xavier Rescigno and Diane B. Rescigno a/k/a Barbara Dianne Rescigno, in this case, No. 3:09-ap-00150-JAF.

2. Plaintiff, American Express Centurion Bank, shall recover from the Defendants, Fred X. Rescigno Sr., a/k/a Frederick Xavier Rescigno and Diane B. Rescigno a/k/a Barbara Dianne Rescigno, the sum of \$7,104.62, plus costs of \$250.00 and interest at the Federal rate. Judgment shall be held in abeyance as long as debtors comply with the terms of the settlement agreement.
