ORDER

This matter came before the Court on the Motions to Compel Discovery from Debtor and for Sanctions (Main Case Doc. No. 32; AP No. 6:08-ap-00023-ABB Doc. No. 6; AP No. 6:08-ap-00024-ABB Doc. No. 11) filed by Central Florida Investments, Inc., the Plaintiff herein (“Plaintiff”), against Kevin Junior Watson, the Debtor and Defendant herein (“Debtor”). The Plaintiff seeks the entry of an Order compelling the Debtor to appear for deposition and for sanctions relating to the Debtor’s failure to appear for a scheduled deposition. Also pending is the Plaintiff’s Objection to Debtor’s Claimed Exemptions (Main Case Doc. No. 21).

Hearings were held on June 23, 2008, July 10, 2008, August 12, 2008, November 3, 2008, December 10, 2008, and January 12, 2009. The hearings were continued to allow a Florida State Court proceeding against the Debtor to conclude. Counsel for the Debtor was directed at the January 12, 2009 hearing to communicate with the Debtor within two weeks and coordinate discovery. The Debtor filed a Withdrawal of Motion for Leave to Withdraw and Status Report to Court (Main Case Doc. No. 60) withdrawing counsel’s Motion for Leave to Withdraw (Main Case Doc. No. 58) and stating the Debtor’s deposition had been re-set for February 6, 2009 at 10:00 a.m. at the office of Debtor’s counsel.

No further filings regarding these matters have been made. This matter is due to be set for a status conference.

Accordingly, it is

ORDERED, ADJUDGED and DECREED that the parties are hereby directed to appear for a status hearing on the Plaintiff’s Motions to Compel and Objection to Exemptions on May 5, 2009 at 11:00 a.m. in Courtroom A, Fifth Floor, 135 West Central Boulevard, Orlando, Florida 32801.
