Due the impact of Hurricanes Helene and Milton on communities within the Middle District of Florida, the courthouses in each division were closed as follows:

(a) The Tampa Division of the United States Bankruptcy Court for the Middle District of Florida was closed on September 25, 26, and 27, 2024 (Hurricane Helene) and on October 8, 9, 10, and 11, 2024 (Hurricane Milton). The Tampa Division resumed normal operations after Hurricane Helene on September 30, 2024, and after Hurricane Milton on October 15, 2024.

(b) The Jacksonville Division was closed on September 26, 2024 (Hurricane Helene) and on October 9 and 10, 2024 (Hurricane Milton). The Jacksonville Division resumed normal operations after Hurricane Helene on September 27, 2024, and after Hurricane Milton on October 11, 2024.

(c) The Orlando Division was closed on September 26, 2024 (Hurricane Helene) and on October 9, 10, and 11, 2024 (Hurricane Milton). The Orlando Division resumed normal operations after Hurricane Helene on September 27, 2024, and after Hurricane Milton on October 15, 2024.

Under Rule 9006(a)(3) of the Federal Rules of Bankruptcy Procedure, unless the court orders otherwise, if the clerk's office is inaccessible on the last day for filing under Rule 9006(a)(1), then the time for filing is extended to the first accessible day that is not a Saturday, Sunday, or legal holiday.

Accordingly, it is

ORDERED:

1. If the last day for filing in cases pending in the Tampa and Fort Myers Divisions fell on September 25, 26, or 27, 2024, the time for filing under Rule 9006(a)(3) was extended to September 30, 2024.

2. If the last day for filing in cases pending in the Tampa and Fort Myers Divisions fell on October 8, 9, 10, or 11, 2024, the time for filing under Rule 9006(a)(3) was extended to October 15, 2024.


3. If the last day for filing in cases pending in the Jacksonville Division fell on September 26, 2024, the time for filing under Rule 9006(a)(3) was extended to September 27, 2024.

4. If the last day for filing in cases pending in the Jacksonville Division fell on October 9 or 10, 2024, the time for filing under Rule 9006(a)(3) was extended to October 11, 2024.

5. If the last day for filing in cases pending in the Orlando Division fell on September 26, 2024, the time for filing under Rule 9006(a)(3) was extended to September 27, 2024.

6. If the last day for filing in cases pending in the Orlando Division fell on October 9, 10, or 11, 2024, the time for filing under Rule 9006(a)(3) was extended to October 15, 2024.
